Whingeing Jocks?

- Is Scotland really any different from the rest of the UK?
- Scottish parliament
 - Separate legal/ education systems
- Geography
 - 1/3rd of UKs landmass
 - 1/10th of UKs population
 - Almost 100 inhabited islands



Scottish politics

- Holyrood parliament
 - Proportional representation
 - Scottish National Party minority administration
- Tax varying powers
 - Reserved matters- e.g. defence
 - Health services evolving apart (BMJ)
- Westminster parliament
- Prime minister and chancellor
 - Over- represented in cabinet!



Bank of Scotland: History

- Oldest surviving bank in what is now the United Kingdom
- Only commercial institution created by the Parliament of Scotland to remain in existence when Holyrood parliament established
- First bank in Europe to print its own banknotes.



Scottish banks in predatory mode

- Pursuit of NatWest in 2001
 - Royal bank won
 - Motto: Firm
- Bank of Scotland woos Halifax
 - Motto: Uberior ("More trustworthy")
- Recent history
 - Both over- reached themselves
 - RBS now 70% state owned
 - HBOS taken over by Lloyds/ TSB



Lloyds TSB takeover of HBOS

- 4th and 5th largest banks in UK
 - 30% of personal current accounts in Scotland
 - 50% of small business services in Scotland
- "Call it off...a mistake"
 - Economist, 8th Nov 2008
- Most senior jobs moving south
- Branch closures

What can the churches do?

- "Holding out the word of life" (Phil 2: 16)
- establishing credit unions
- utilising space in congregational buildings for
 - community food co- operatives
 - community social events: e.g. cinema nights, ceilidhs
- using the practical skills and experiences that many church members have
 - e.g. baking/ cooking classes
 - babysitting circles
- organising "car pools" to help people get to
 - the doctors surgery/ hospital visiting
 - the supermarket/ town centre

What can the churches do?

- Significant sum from church's resources be made available for specific practical projects
 - at parish or presbytery level
- Series of consultation meetings proposed
